Healthcare Problems Facing States

- Increasing number of uninsured
- High cost of healthcare and impact on business (large and small employers)
- Medicaid as we know it is unsustainable
- Just controlling costs is not enough
- Sense that something needs to change

New Opportunities for Change

- Tackle many healthcare problems at once
- Substantially reduce number of uninsured
- Tear down wall between Medicaid and the uninsured
- Increase access to affordable health coverage, esp. for small business
- Make big change in a bipartisan manner
- Forge a new partnership with the feds
- Positively impact residents' health status

Federal-State Dynamics

- Feds encouraging state-based reform
- Feds are open to bold, creative approaches
- DRA gives states some flexibility
- What feds are looking for in state-based reform
 - Private market solutions
 - DRA-based flexibility
 - Health insurance Exchange/Connector
 - More managed care esp. of high-needs individuals
 - Premium subsidies **not** provider payments
 - Savings
 - Consumer Responsibility
 - Budget neutrality, if 1115 waiver needed

How States are Addressing Health Reform

Real reform is a mix of money, public policy and private insurance:

- Medicaid Financing
- Insurance market reforms
- Subsidized and unsubsidized options
- High risk pools
- Reinsurance
- Exchange/Connector concept
- Limited benefit packages
- More managed care

Ultimately, it all comes down to:

- The business climate, and
- Access to affordable coverage

What Does Mass. Reform Look Like?

1. Coverage:

- Maximize and streamline Medicaid enrollment to those eligible, but not yet enrolled
- Create subsidized version of Commonwealth Care for low-income uninsured
- Create unsubsidized version of Commonwealth Care for higher income uninsured
- 2. Individual Mandate: Personal Responsibility Principle
- 3. Insurance Market Reforms: Small Group & Individual Markets

4. Medicaid s. 1115 Waivers:

- ⇒ Leverage existing state dollars
- ⇒ Retain, redirect federal dollars


5. Reforms to Contain Costs:

- ➡ Transparency
- ➡ E-health initiatives
- → Program integrity
- ➡ Medical malpractice reforms

6. The Connector:

- ⇒ Leverage pretax dollars
- Connect individuals, employers and health plans

What Are Other States Doing?

Michigan

 Governor Granholm's Healthcare Reform Project seeks to significantly expand healthcare coverage to the state's 1.1 million uninsured

Indiana

 Governor Mitch Daniels is looking to the private market and subsidies for HSA-type insurance

Washington

- Governor Christine Gregoire is co-chairing her state's *Blue Ribbon Healthcare Commission* to improve access to affordable healthcare for all Washingtonians

New Mexico

 Health Coverage for New Mexicans Committee to explore various reform options for extending coverage

Massachusetts Reform and Private Sector Business

Opportunities from Coverage Expansion

- Comprehensive health insurance coverage initiatives potentially bring hundreds of thousands of additional lives to the market
- Cost-shifting due to care for the uninsured will be lessened
- States are keenly interested in bringing people to the table who largely haven't been there previously (employers and insurers)
